Executive Director

Principal

It is the policy of Compass Montessori for the Executive Director to determine the annual salary of it's Principals commensurate with years of experience, education level, job performance and allowable budget.

Administrative Support Staff

It is the policy of Compass Montessori for the Executive Director to determine the annual salary of it's Administrative staff based on years of experience, education level, job performance and allowable budget.

Before/Aftercare/Summer Program and other Hourly Educational Support Staff

It is the policy of Compass Montessori to pay it's Before/Aftercare, Summer Program, and any other hourly educational support staff an hourly wage that complies with the "Fair Labor Standards Act" and is competitive with similar job descriptions.

Note: All employment at Compass Montessori is "at will" and can be terminated by either party at any time. All full time employees and any part time employees working more than 30 hours per week, are eligible for Jeffco's offered health insurance.
